- ❖ A candidate who has passed a Master Degree examination [ M.Sc.] in Nursing from a recognized institute/University which is recognized by the Indian Nursing Council- INC.

### Admission Process

- ❖ The admission process consists of Two phase
  1. Written test of TWO hours duration with 100 MCQ Question comprising of 25 MCQ for Research Methodology, 25 MCQ for General knowledge and 50 MCQ for Speciality Subject of the concerned Faculty.
  2. Personal interview and brief presentation about proposed research topic.
- ❖ The selection will be made purely on merit basis of marks secured in MAM University's Ph D Entrance Examination and personal Interview and upon the availability of the seats.

- ❖ Candidate is supposed to submit self-attested copies of S.S.C., H.S.C., UG, PG Marksheets at the time of counselling.
- ❖ The candidate is solely responsible for his/her eligibility and the information which he/she has furnished in the application form.
- ❖ The candidate already in service will be required to submit NOC at the time of counseling along with written assurance that if selected, the employer will relieve him/her for the research work as per the norms of MAM university. No relaxation will be permissible.
- ❖ No stipend will be given to the Ph D Scholars.
- ❖ Annual fee for Ph D will be RS 1,20,000/- (one lakh twenty thousand).
- ❖ If two candidates of the same category get equal marks in entrance test, their total marks of final year PG theory exam will be considered for merit place. In case where the total of final year PG marks are also found equal, total marks of the UG standard will be considered to decide merit.
- ❖ Scholars appearing in their Post-Graduation Final Year Examination can also apply, however their admission will be subjected to the result of final examination declared before the date of counseling.
- ❖ The registration of candidates for Ph d. program shall be considered as provisional till the candidate successfully completes Course work exam.
- ❖ The regulations for Doctor of Philosophy [Ph. D] program is available on the university website: [mamuni.edu.in](http://mamuni.edu.in)
- ❖ Admission will be governed by the rules and regulations for the Doctor of Philosophy [Ph. D] program -2022 of MAM university.

### International Student

International students can apply via two streams:

- ❖ One may directly apply to MAM University through e-mail to the address "registrar@mamuni.edu.in". The email must include Cover letter, CV, research statement, scan of information page of passport, transcripts and the letter of recommendation.
- ❖ Also indicate your nationality and describe your academic track record in your CV. In your cover letter, indicate the department of your interest along with the name of potential Ph D supervisor.

- ❖ One may also apply through the 'Study in India' Programme launched by the Ministry of Human Resource Development.
- ❖ Only foreign nationals can apply in the international student category.
- ❖ At the time of admission, the applicants must have completed Undergraduate degree and post graduate degree in relevant discipline from an institution located outside India.
- ❖ Candidate has to obtain an equivalence certificate from the competent authority in India.
- ❖ At the time of counselling candidate has to submit all the necessary academic and identity documents
